## Memorandum of Cooperation

between

Ministry of Health

and

NGO- “Kosova Red Crescent“

Given the common interest on advancing the medical and health services in Kosova;  
Based on the objective for the advancement of exchanges in health services with other countries in favour of increasing the cooperation between Kosova health institutions and relevant world-renowned institutions;  
With the common goal to create new opportunities for health services;  
Considering as one of the priority objectives in exercising medical services in general and provision of health services in particular, according to the European standards;  
Given the success of humanitarian project implemented by the Ministry of Health and Red Crescent for the transplantation of 10 ear plants, in value of 200,000 Euros.  
Affirming their goodwill and determination to cooperate and contribute in a constructive and essential manner for fruition of the purpose of this memorandum;

**Ministry of Health (MH)** represented by Prof. Dr. Ferid AGANI the Minister, address: Str. Zagreb. Prishtina and,

**Kosova Red Crescent (KRC)** a Humanitarian Association with registration number: 5111078-1, represented by the Executive Director, Mr.sc. Adem Ademi, address: Str. "Bill Clinton" No. 21 Lakrishtë- Prishtina,

Conclude this **Memorandum of Cooperation** in accordance with the following provisions:

### **Article 1 Purpose of the Agreement**

This memorandum is to define the scope of cooperation between the two parties, humanitarian projects and cooperation in other areas of health in accordance with this Memorandum of Cooperation

### **Article 2 Scope of Cooperation**

The MH and KRC agree to cooperate in the following areas;

1. Cooperation between both parties in preparation and implementation of projects in the given areas of Health.
2. Cooperation on meeting the needs of Kosova hospitals with modern medical equipment and technology.
3. Sending staff for professional training in relevant institutions abroad.
4. Sending abroad for treatment the seriously ill patients that cannot be treated in private or public institutions of Kosova, individuals on social assistance, poor and the individuals from the families of martyrs based on capabilities and provided donations.
5. Bringing to Kosova of the professional medical staff and international specialists doctors.

6. Cooperation and inter-institutional thematic campaigns for general good as are: protection of public health and health rights.
7. Facilitating the implementation of the different research studies of a relevant importance for citizens and for the authorities of Ministry of Health;

### **Article 3**

#### **Party Liabilities**

1. The MH provides KRC with support on ideas and projects in the field of health in Kosova.
2. The MH suggests to KRC on projects, priority needs and requirements in the field of health that need to be implemented.
3. The KRC retains the right on calculating annual material expenses that are necessary for implementation of the joint humanitarian projects with MH, as part of humanitarian project costs.
4. The KRC notifies MH in written about contacts and cooperation with relevant institutions on project implementation.

### **Article 4**

#### **Evaluation of the Implementation of the Memorandum**

1. The parties commit to jointly assess the functioning of cooperation mechanisms through drafting and submission of a written report to the officials of both parties.
2. The final joint report includes, in addition to data about the implementation of the memorandum, concrete recommendations for addressing identified needs.

### **Article 5**

#### **Financial Costs**

Financial costs resulting from the implementation of this Memorandum shall be subject to the legislation in force and are within the budget limits that Ministry of Health has in its availability.

### **Article 6**

#### **Duration of the Memorandum of Cooperation**

1. Memorandum of cooperation is the will of both parties to improve the situation in Kosova health sector and is a long term humanitarian process that initially is signed to a three-year term.
2. Memorandum of cooperation between the two parties could be amended in writing, if need be, with the consent of both parties.

**Article 7**  
**Language Used**

The document of memorandum of cooperation between the Ministry of Health of the Republic of Kosovo and the Kosova Red Crescent is written in Albanian and English.

**Article 8**  
**Consent of the Parties**


1. The Parties shall act in full confidence to ensure the achievement of all objectives of the agreement.
2. Disagreements or different possible interpretations of the items of this agreement shall be governed in a friendly manner and with consensual agreement.


**Article 9**

The memorandum is drafted and signed in 2 (two) original copies, one of which shall be archived at the Ministry of Health and the other one at the KRC.

**Article 10**

This memorandum is signed dated on \_\_\_\_\_ in Pristina, and shall enter into force upon its signature.
